Contract For Wedding Photography Services

This constitutes an agreement for photographic services. It is also understood that any and all negatives or digital images remain the property of the photographer, Scott R. Wilson, dba Houston Event Photography and they may be used for advertising, display or any purpose thought proper by Houston Event Photography.

The photographer for this event will be Scott R. Wilson. Studio/photographer may substitute another photographer to take the photographs in the event of photographer's illness, family emergencies, or scheduling conflicts beyond the control of the Studio/Photographer. In the event of such substitution, photographer warrants that the photographer taking the photographs shall be a competent professional and made available at *No Extra Charge*.

Houston Event Photography and its photographer(s) shall not be held accountable for any unforeseen delays in the order(s). Digital files are kept for three years and may be purchased by the client after that time. It is the client's responsibility to contact the photographer for their digital files. Digital files will be stored on hard disk drives or DVD/CD for three years.

If the photographer cannot perform this Contract due to fire or other casualty, theft, strike, refusal onto property, refusal to allow photography on premises, act of God, or other cause beyond the control of the parties, or due to photographer's illness or emergency, then the photographer shall return the retainer to the Client but shall have no further liability with respect to the Contract. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera or equipment malfunction, computer or digital media card malfunction, under exposed or color shifted due to only available light photography being allowed at location or otherwise lost or damaged without fault on the part of the photographer. Although all care will be taken with the digital media and photographs taken at the wedding, the client agrees that the photographer limits any liability for loss, damage, or failure to deliver pictures, for any reason, to no more than the return of all payments made to photographer.

Photographer is the sole professional photographer allowed to photograph the event. Amateur photographers may take photos during the event if they do not interfere with the contracted photographer and only after the contracted photographer has finished taking the contracted or posed photographs. If interference happens the contracted photographer will notify the designated family representative on site to handle the situation.

Upon signature, photographer reserves the time and date agreed upon, and will not make other reservations for that time and date. For this reason, all payments are nonrefundable and nontransferable, even if the date is changed, postponed or the wedding is canceled for any reason. All payments are due and payable in Harris County, Texas.

A non-refundable retainer is due at signing of this contract. The retainer will be equal to ½ of the current full cost of the service requested. At the photographer's discretion, a partial retainer may be accepted to hold the date. Another payment of ½ of the balance due is to be paid on the service date and the final payment if any is due upon delivery of the final order. No part of any order, including previews, if any, will be delivered until the balance is paid in full. Prices are subject to Texas and Local Government sales tax. All payments are to be made in Harris County, Texas. The studio is not bound until the nonrefundable retainer is paid and accepted and this agreement is signed. This Agreement may be executed in any number of counterparts confirmed by facsimile signatures transmitted by telephone or email each of which shall be deemed a duplicate original.
